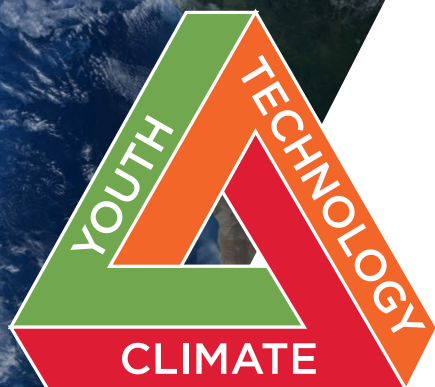

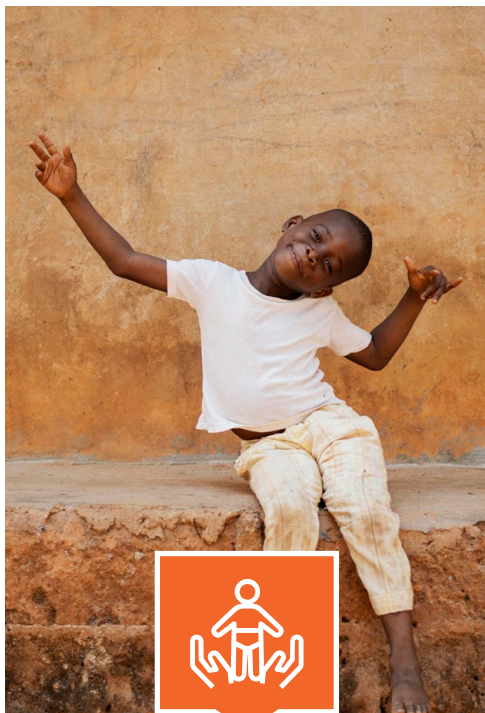

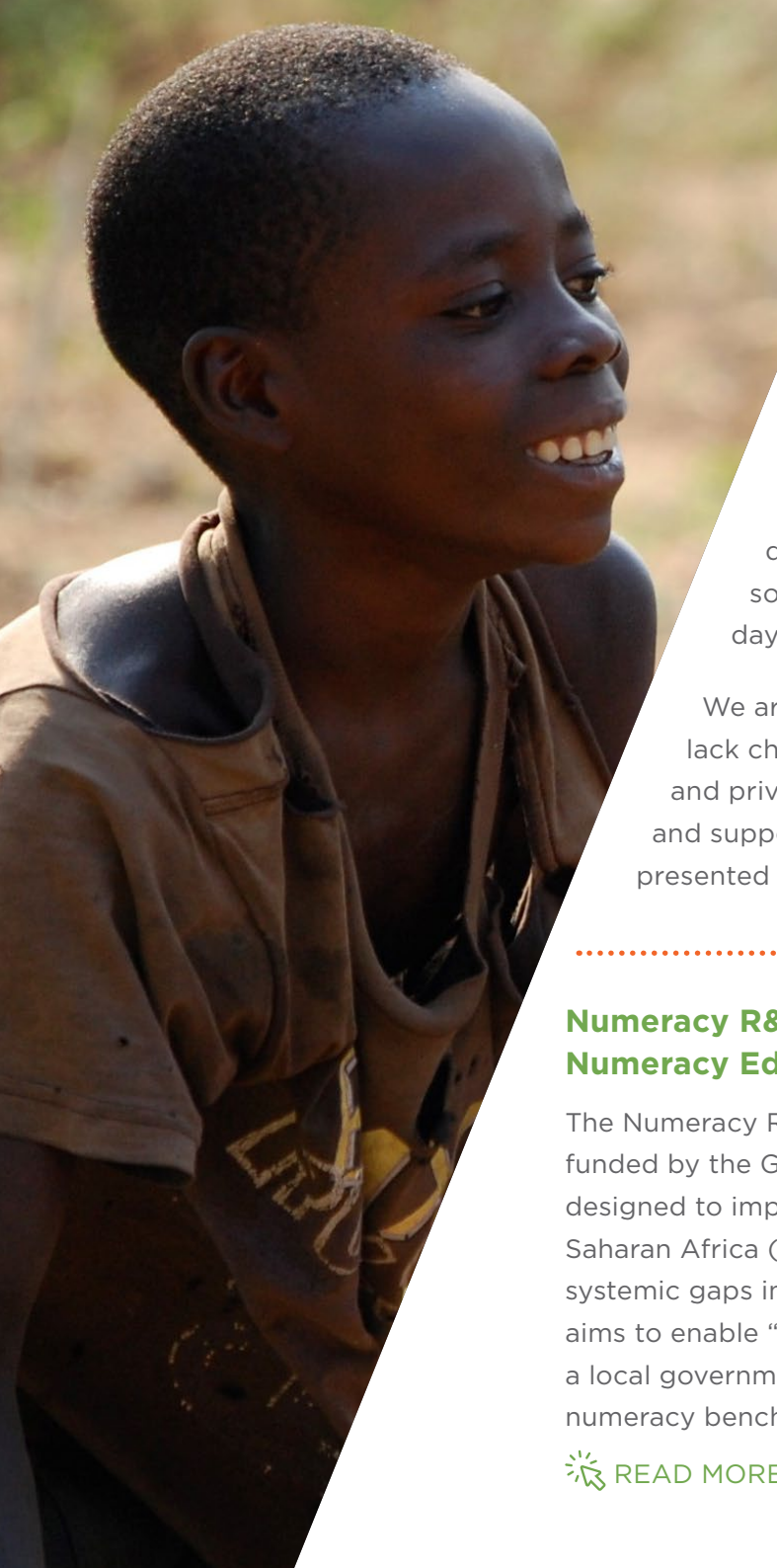

YOUTH, EDUCATION & EARLY CHILDHOOD DEVELOPMENT



Half the population in Africa is below the age of 20.

We are committed to helping these young people, and their peers in the Middle East, develop to their full potential and make a positive contribution to their communities and societies. We work to improve education, care and support from the critical first 1,000 days of life, through k-12 education, up to young adults' entry into the world of work.

We are particularly focused on expanding opportunities for children and young people who lack choice and opportunity. We work with governments, their partners in development, and private and non-state actors to improve the reach and quality of education, care, and support services. We help clients to take opportunities and deal with challenges presented by changes in demography, climate, technology and the shock of COVID-19.

Numeracy R&D Challenge Fund: Transforming Numeracy Education for Global Impact

The Numeracy Research and Development (NRD) Challenge, funded by the Gates Foundation, is an ambitious initiative designed to improve foundational numeracy outcomes in Sub-Saharan Africa (SSA) and South Asia (SA). By addressing systemic gaps in numeracy pedagogy and evidence, the program aims to enable “50% of government school students within a local government administrative level to reach Grade 3 numeracy benchmarks after 3 years of intervention.

Moho Mhlaba Schools is a low-fee independent primary school in Khayelitsha, South Africa, with a vision of providing safe, affordable, quality education to girls in the community in which they live. The assessment included a detailed appraisal of Molo Mhlaba's pedagogical approach to schooling.

Reimagining higher education in South Africa

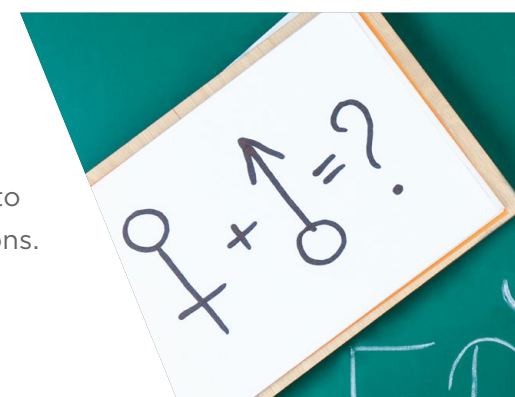

Managing risks, such as the risk of ill health, poor rains or losing a job, forces many vulnerable people in Africa and the Middle East to put themselves in difficult situations. We are committed to helping people manage risks and deal with shocks.

We help governments, their partners and non-state actors understand the risks that affect their populations, including both “fat tail” risks such as COVID-19, conflict, or catastrophic climate change, as well as risks associated with being young or old and those related to disease, the economy, accidents and crime.

Ensuring the greatest impact of COVID-19 relief funds in SA

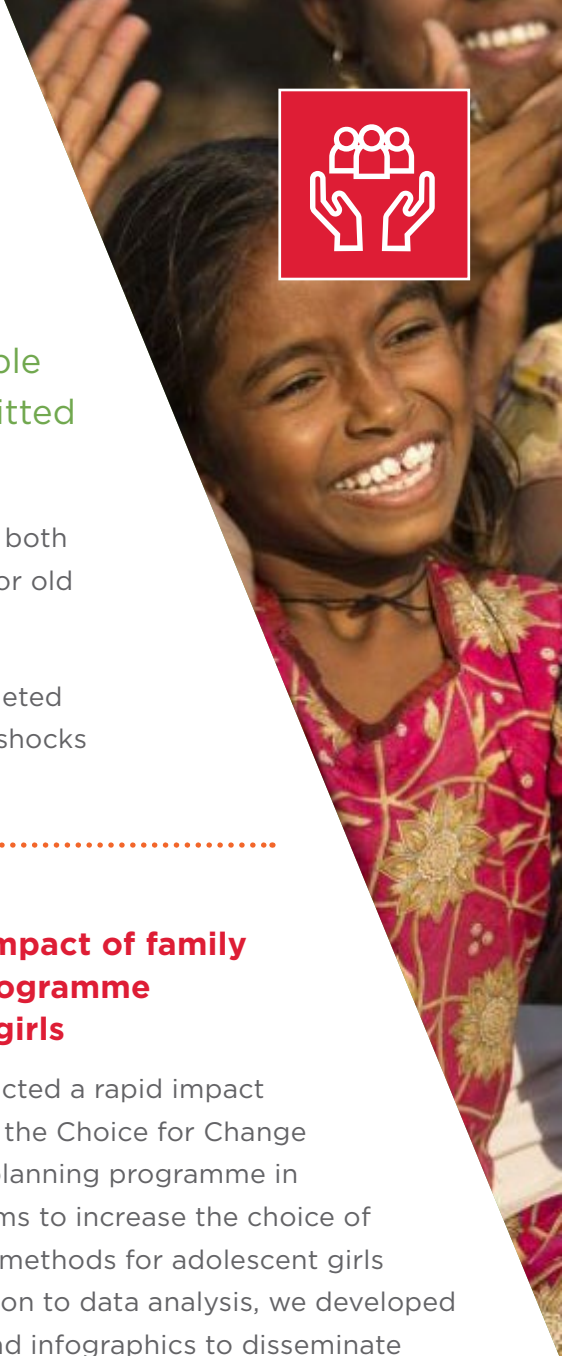

The Gates Foundation contracted Genesis to provide technical support for the fund to ensure that investments made by the fund had the greatest possible impact. These initiatives included a food voucher system and support for organisations tackling gender-based violence.

Assessing impact of family planning programme for Kenyan girls

Genesis conducted a rapid impact assessment of the Choice for Change (C4C) family planning programme in Kenya. C4C aims to increase the choice of contraceptive methods for adolescent girls there. In addition to data analysis, we developed data visuals and infographics to disseminate the findings and sustain the work of C4C.

Innovative funding for project to address teenage pregnancy

Reducing unintended pregnancies and HIV infections in girls are among the aims of a South African Medical Research Council initiative. It is funded by a social impact bond (SIB) whereby a social investor provides working capital and is only repaid if successful outcomes are achieved. We were part of a consortium that provided technical support for the SIB process – from the design of the SIB to investor mobilisation and co-creation of the project and its target results.

Addressing food security in a global pandemic

We advised the Solidarity Fund on how it could support a sustainable food production intervention to the most vulnerable households in South Africa, where livelihoods had been aggravated by COVID-19. With the support of the Gates Foundation, we designed a R120-million agricultural inputs voucher targeting smallholder farmers in rural South Africa. This digital voucher enables them to continue vegetable production for their own consumption, even when food value chains are disrupted as was the case with COVID-19.

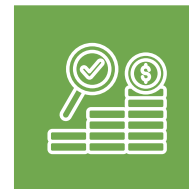
Early flood forecasting system for Incomati Basin

The Incomati River Basin spans South Africa, Swaziland and Mozambique. As part of the Climate Resilient Infrastructure Development Facility, Genesis was engaged for three years to support holistic flood mitigation there as the financial and economic adviser on the project. We evaluated various flood mitigation responses and recommended a way to proceed with the choice and financing of the infrastructure. Our work was integral to establishing the need for an early warning flood forecasting system and its requirements for financial sustainability.

SOCIAL SECTORS FINANCING



We support solution design, backed by understanding the contexts within which we live and work. In addition, we support implementation, where we provide catalytic expertise to existing systems. We strive to create a world where everyone, particularly those marginalised, can achieve their full potential.

Our specialisation encompasses landscape analysis, macroeconomic analysis and forecasting. We focus on financing, budget, and expenditure tracking and analysis. We conduct costings, investment cases, cost-benefit analysis, efficiency and equity analyses, among others. Our data analytics capabilities are integral to our mission, leveraging frontier technology and methodologies to drive insights and solutions. We employ robust techniques for data extraction, ensuring accuracy and relevance, and ensuring efficiency in transforming raw data into structured formats suitable for advanced analysis.

Counting the health costs of VAT on soap in Madagascar

The cost of soap in Madagascar is an obstacle to handwashing which in turn has health implications. While scrapping VAT on soap would lower its price, this would also reduce fiscal space. Using a cost-benefit analysis, we generated economic evidence on the short- and long-term potential impact by applying the measure compared with the current situation. We also provided insight on how variations in the design of the intervention would impact the results.

Supporting Uganda to prioritise cost-effective investments in nutrition

Undernutrition is the underlying cause of a third of all deaths in children under five years old. In this context, Uganda is developing a multi-sectoral national nutrition policy and action plan covering the period 2019 to 2025. Genesis is supporting UNICEF and the Ugandan government in developing an investment case to guide stakeholders on where to focus limited resources. We are also costing the plan according to different roll-out scenarios that depend on varying levels of resources.

The approach is also aimed at achieving the goals in the Paris Agreement, the Sendai Framework for DRR and the Sustainable Development Goals.

Marshalling financing for Tunisia's sustainable development

To meet its development goals, Tunisia requires substantial and sustainable funding. This has been highlighted in its Nationally Determined Contribution, which estimates a need of \$19.4 billion to implement mitigation and adaptation actions for climate change. Moreover, reliance solely on the public sector for financing Sustainable Development Goals (SDGs) is inadequate.

Diagnosing expenditure performance through health financing analysis

We assessed the performance of six countries' health financing systems to understand performance and identify entry points for improvement. Using a suite of health financing and analytical approaches, benchmarking, regression and trend analysis, we supported the creation of country health financing dashboards.

Building the case for an investment in ECD in Burundi

About two out of three children below five years old in Burundi are at risk of not achieving their full potential due to delays in their early childhood development (ECD). However, the current spending in ECD in Burundi reflects underinvestment and low prioritisation. Our Human Development team partnered with UNICEF and the government of Burundi to build the case for multi-sectoral ECD investments in the country and to recommend the package of ECD interventions that is optimal to boost the development of its youngest generation and, accordingly, of the nation as a whole.

Impact of in-school classes for budding entrepreneurs

The startUP&go programme aims to foster a culture of entrepreneurship by supplementing the curriculum resources for use in the classroom. Genesis conducted an impact evaluation targeting learners who had completed three years of the programme. This will inform roll-out of the programme to more schools.

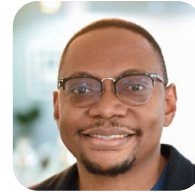

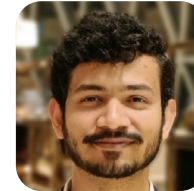

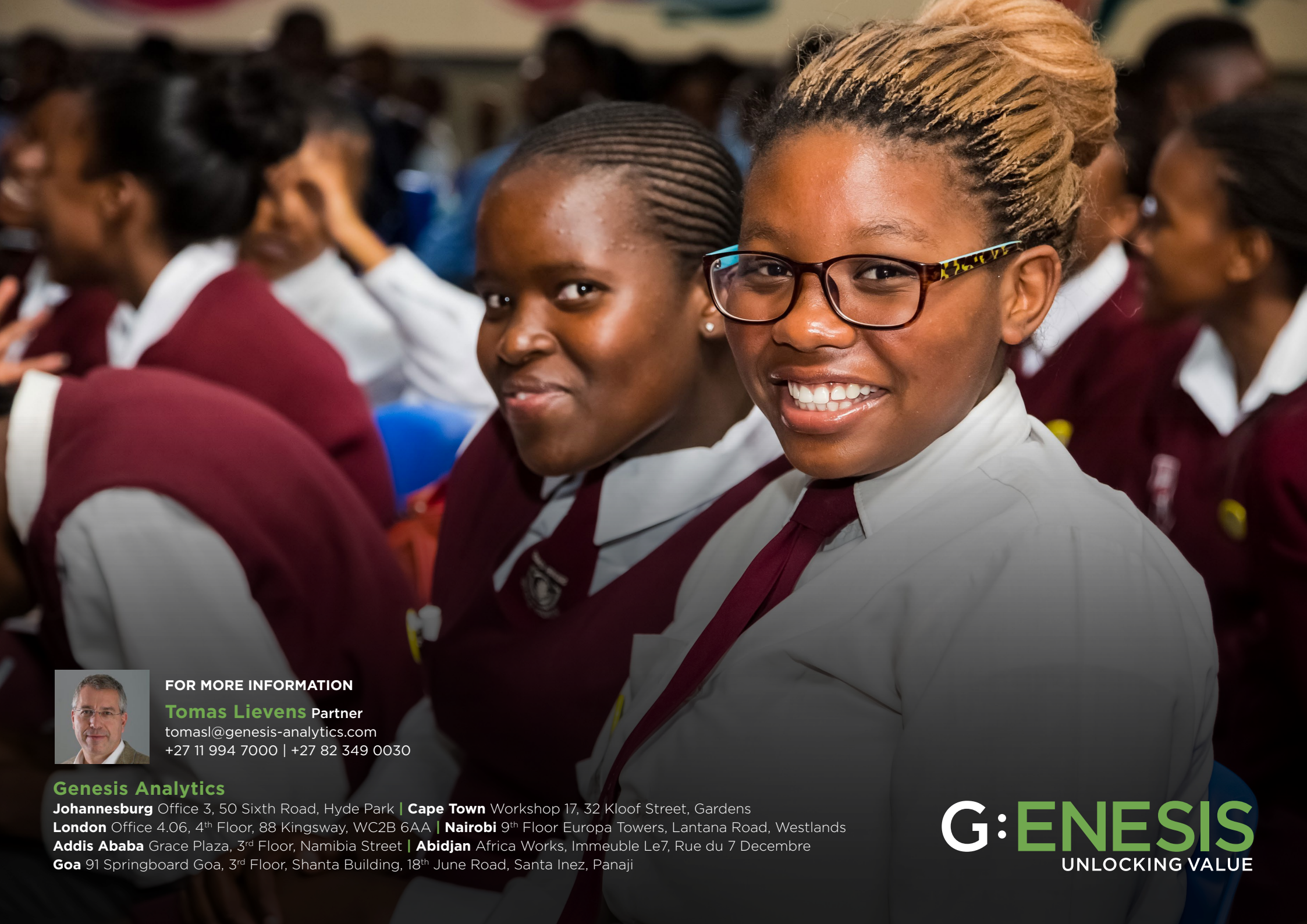
